

£75 Cash back promotion Terms and Conditions

- 1) The £75 Cash Back promotion ("Promotion") is open to UK small businesses and residents who are 18 years or over. Employees (or family members of employees) of Talk Warehouse, its affiliates, subsidiary companies and any representatives or anyone else who may be professionally involved with the Promotion may not enter. Talk Warehouse reserves the right to verify the eligibility of entrants. This promotion is limited to the original intended recipient of the promotional material of Talk Warehouse.
- 2) The Promotion begins 00:00:01 BST on 1st January 2009 and finishes when 100,000 entrants have successfully applied for their Cashback. Successful entrants must maintain a minimum monthly spend of £30 per month in order to qualify for £75 cash back.
- 3) To be a successful entrant and to be eligible to receive a £75 cash back, entrants must: (i) have a valid Talk Warehouse landline account or must register for a valid Talk Warehouse landline account if they have not already done so; and maintain payment by Direct Debit. Late payment or failure to maintain payment by direct debit will disqualify applicants from this promotion.

This must be claimed by completing a redemption voucher which is available by calling our customer services department on 08444127272 and sent back to us accompanied with copies of your last twelve months bills. All claims must be submitted no more than 30 days after the anniversary date of the activation of the Sim card. Claims submitted beyond this date will be invalid.
- 6) A list of Successful Entrants' names and counties of residence will be available for one month after the end of the Promotional Period, by sending a stamped self addressed envelope (SSAE) to us.
- 7) In the event of any circumstances arising outside of Talk Warehouse's control, which in Talk Warehouse's opinion makes it necessary to suspend, change or cancel the Promotion, Talk Warehouse reserves the right to suspend, change or cancel the Promotion at anytime.
